

# INFORMATION ABOUT COOKIES

*ON WEBSITES OF BONATRANS GROUP*

## I COOKIES DESCRIPTION

The personal data controller and operator of this website, the joint stock company BONATRANS GROUP a.s., having its registered seat at the address Revoluční 1234, 73594 Bohumín, Czech Republic, Business ID No: 27438678, Tax ID No: CZ27438678, entered in the Companies Register kept at the Regional Court in Ostrava, section B, inset 3173, (hereinafter “the **Operator**”) uses on this website cookie files which:

- a. are essential for the proper functioning of the website and remembering the website visitor's choice regarding cookies. Without these cookies, the website would not work properly (Technical cookies);
- b. collect information about how the website visitor uses the website, which pages he or her visited and which links clicked on. It concerns Google analytics cookies only. All of the data are anonymized and cannot be used to identify the website visitor (Analytics cookies).

## II TECHNICAL COOKIES

The use of Technical cookies under clause I a. above is necessary for the proper functioning of the website and according to the law does not require the visitor's consent.

## III PERFORMANCE AND ANALYTICS COOKIES

The Operator is allowed to store cookies mentioned in clause I b. above or to gain access to such cookies stored in the terminal equipment only under the condition that the website visitor has given his or her consent, having been provided with clear and comprehensive information. This shall not prevent any technical storage or access (i.e. storage and reading of Technical cookies under clause I a. above). The website can also be used in a mode which does not allow the use (i.e. storage, reading and processing) of cookies mentioned in clause I b.. The consent to the use of cookies mentioned in clause I b. above is not mandatory and can be revoked at any time. The website visitor can give the consent to the use of those cookies via buttons on the website. The website visitor may also withdraw his or her consent at any time by using the „Cookies preferences“ button on the homepage of the website..

## IV PERSONAL DATA PROCESSING

Use of cookies with the aim specified in clause I b. is also considered to be personal data processing. This processing is only possible on the basis of a lawful reason – the consent of the website visitor, and it is allowed by article 6 paragraph 1 a) of Regulation of the European Parliament and of the Council (EU) 2016/679 on the

protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereafter the "Regulation").

## V PROCESSING PERIOD

Technical cookies essential for the functionality of the website shall be kept only for the period:

- php session id cookies - only for the duration of the connection to the website
- cc cookies - for 3 months

Analytics cookies – Google Analytics cookies - shall be kept by the Operator for the maximum time period of 2 years.

## VI PROCESSORS

Collected Analytics cookies may be processed by other processors:

- a. Google Inc., having its registered office at the address 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA. 7, provider of services Google Analytics.

## VII RIGHTS OF THE WEBSITE VISITOR

Please take note that according to the Regulation and regarding cookies mentioned in clause 1b. above you have the right:

- a. to revoke your consent with personal data processing,
- b. to require of the Operator information about which of your personal data it processes,
- c. to require of the Operator access to this data and have it updated or rectified or to have its processing restricted,
- d. to require of the Operator the erasure of this personal data – the Operator will perform erasure if the erasure does not contravene applicable laws and the legitimate interests of the Operator,
- e. should you have any doubts about adherence to the obligations associated with personal data protection, contact the Operator or Personal Data Protection Office.
